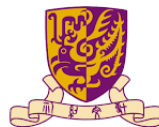

The 13th Asia Impact Assessment Conference cum the 6th China Strategic Environmental Assessment Forum will be held in Hainan, China on 22-23 August 2019. The conference is jointly hosted by Nankai University, Beijing Normal University, the Chinese University of Hong Kong and the Hong Kong Institute of Environmental Impact Assessment.

The China Strategic Environmental Assessment (SEA) Forum jointly organized by the Nankai University and the Chinese University of Hong Kong was first held in Hong Kong in February 2009. Subsequently, four consecutive SEA forums were successfully held in Tianjin, Kunming, Chengdu and Hong Kong respectively in every other year. The 6th Strategic SEA Forum this year will have a theme of “Applicability of Three Lines and One List” (TLOL) in SEA”, and we aim to discuss on the topics relating to its institutional specifications, technical methods and case examples.
